### **Youth Month Contest Rules**

# 3. Agreement to Official Rules

#### 4. Contest Period

The Contest begins on April 1, 2023 at 12:00am CST and ends on April 30, 2023 at 11:59pm CST (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:

### 5. How to Enter:

Participates must first obtain the official contest bingo form by downloading the form from the official contest page on the firstalliancecu.com website or by visiting a First Alliance Credit Union branch during normal business hours to obtain a copy of the official contest bingo form in person.

Downloading the official contest form requires participate to provide their first name, last name and working email address to First Alliance Credit Union via the official contest form. By

providing this information via the official contest form participates are consenting to receive marketing email communications from First Alliance Credit Union.

Participates must completed five or more official contest activities and mark their activities on the official contest bingo form to complete a row of five squares horizontally, vertically, or diagonally.

Participates must submit their completed forms during the official contest period by either uploading a completed official contest bingo form via the official contest page on the firstalliancecu.com website or by visiting a First Alliance Credit Union branch during normal business hours to submit in person a completed official contest bingo form.

# 6. Prize Drawing

On or about May 3, 2023, the Sponsor will select two potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winners via telephone or email on or about May 05, 2023. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
